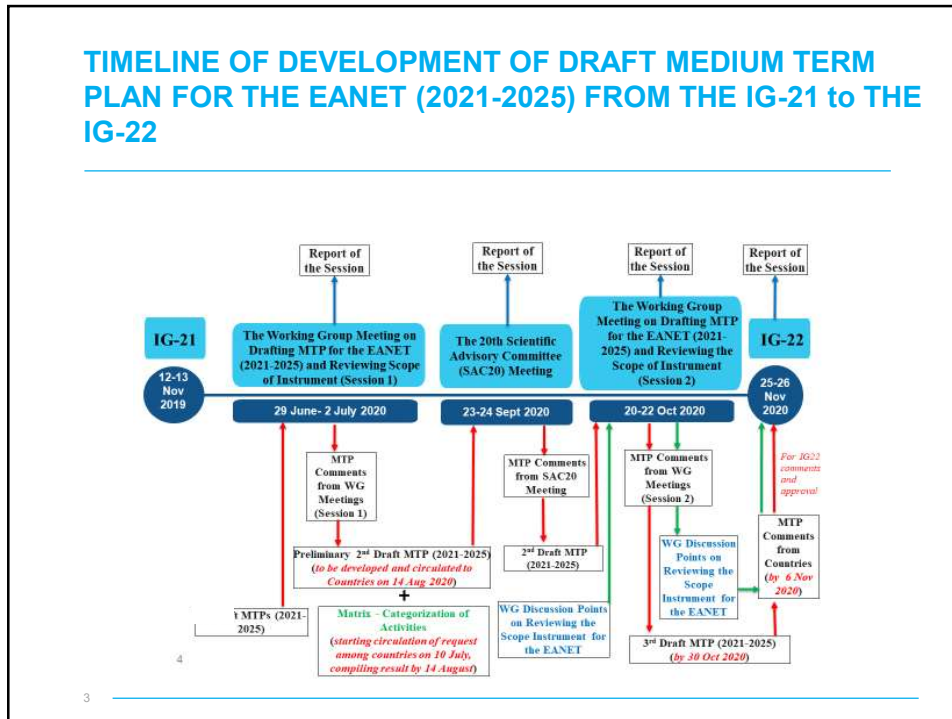
Introduction

- In the **Working Group (WG) Meeting on Reviewing the Scope of Instrument**, the Secretariat delivered the presentation, Proposed Next Steps After the WG Meeting on Reviewing the Scope of Instrument for the EANET (EANET/WG 2/5_rev2). At the Meeting, the Secretariat **proposed the dates of EANET Key Meetings in 2020 and the Timeline of Development of the MTP for the EANET (2021-2025) from the IG21 to the IG22** to be held from 25-26 November 2020.
- By referring to the Timeline of Development of Draft MTP for the EANET (2021-2025) from the IG21 to the IG22 (See Annex), after the Working Group Meeting Session 2 on Drafting MTP for the EANET (2021-2025) and Reviewing the Scope of Instrument for the EANET, the Secretariat and the NC will develop **the 3rd Draft MTP for the EANET by the end of October 2020** for comments from the Participating Countries **before submission to the IG22**. Furthermore, **IG22 will review the 3rd Draft (Final Draft) MTP** and make decisions, as appropriate.

Next Steps

WG: Exchange views on 2nd Draft MTP2021-2025 and 1st Draft WPB2021

SEC&NC: Share the 3rd (Final) Draft MTP on 30 Oct with the PC based on WG discussion.

Questionnaire Survey: PCs are requested to submit their inputs (by 6 Nov) to be sent 23 October 2020

- 1) Priority to each of 27 proposed non-core activities in WPB2021.
- 2) Intention to provide additional voluntary contributions (financial and/or in-kind)
- 3) To identify whether activity is within/ beyond the current scope of the Instrument.
- 4) Other comments on draft of 3rd MTP, 1st Draft WPB2021, Financial & Administrative Guidelines.

SEC & NC: Prepare 3rd (Final) Draft of MTP and Final WPB2021, based on the Survey and then circulate among PCs (by 10 Nov.)

- Activities seem beyond the current Scope will be excluded from WPB2021
- Similar activities may be merged.
- High priority with resource ready activities would be in the list of planned activities to implement.
- Low priority with insufficient resource activities would be in a candidate activities list, which will be selected and implemented, when resource will be secured
