Proposed Next Steps After WG2021-2

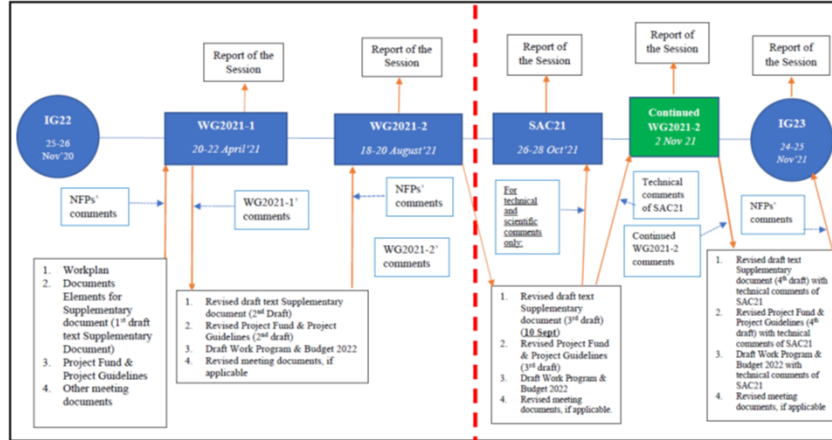

- b. The Friends of the Chair will:
 1. Attend the virtual meeting to discuss about Draft Supplementary Document \ (Annex) to EANET Instrument
 2. Support the Secretariat in providing inputs to the Revision Draft of Supplementary Document (Annex) to EANET Instrument (3rd Draft) before submission to all National Focal Points on 10 September 2021.
- a. The Secretariat may request the Participating Countries to be part of the Friends of the Chair at the Session of WG2021-2. Countries may also inform the Secretariat regarding their intention to be part of the Friends of the Chair before 25 August 2021.

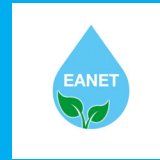
